Thank you for your interest in Downtown Clearwater and the Food and Drink Tenant Grant Program for Bars. To start the process please complete this form by **December 15, 2018**. City staff will review this form and follow-up with you within 10 business days to discuss your eligibility for the grant program.

For the purposes of this grant program, the CRA distinguishes between full service restaurants and bars. *Bars* serve alcoholic drinks and do not have a kitchen or have limited cooking equipment. *Bars* serve pre-prepared food or food that is prepared in a different location from where customers are served. *Full service restaurants* operate a kitchen that serves that serves hot and cold food that is prepared within the same site as the customers being served.

The CRA will provide a grant to reimburse *bars* for improvements made to the building, new fixtures, new furnishings and signage for 100% of their costs, up to a maximum grant of \$30,000. Payment schedules and additional grant agreement requirements are dependent upon the total grant amount awarded. Please see the program description for full details.

3. For bars that are actively under construction and will open no later than July 1, 2019:

- a. Briefly describe your business including operating hours, a description of the space and the types of food/drink you will provide.
- b. List all of the building improvements, furniture, fixtures, equipment and signage that you plan to build or purchase to open your business and their costs.
- c. Provide a copy of your building permit.
